On October 5, 2012, Bonetti Explosives received four containers (55-gal drums) containing Materials Documented As Safe (MDAS) from Zapata Incorporated, originating from the former Camp Croft, Spartanburg, South Carolina. The estimated shipping weight at the time of shipment was 4,500 lbs. The actual weight of the contents in the four containers was 2,904 lbs.

This letter is to verify that Bonetti Explosives, LLC has smelted 2,904 lbs of MDAS sent by Zapata Incorporated. The contents of these sealed containers were not sold, traded or otherwise given to another party until the contents were smelted and were only identifiable by their basic content. On November 14, 2012 the material was dispositioned into civilian recycling in accordance with EM 1110-1-4009; this is your final letter regarding this matter.
