# BY GARY HAYES:

I WANT TO WELCOME EVERYBODY. I'M GARY HAYES. TONIGHT IF YOU'VE GOT SOMETHING TO SAY, WHEN YOU HAVE SOMETHING TO SAY, PLEASE SPEAK CLEARLY, STATE YOUR NAME AFTER YOU'VE BEEN RECOGNIZED, AND WE'LL FOLLOW UP FROM THERE. I APPRECIATE EVERYBODY COMING. WE'VE GOT A GOOD AGENDA TONIGHT. AT THIS TIME, I WANT TO TURN IT OVER TO RON NESBITT. HE'S GOING TO TALK TO US ABOUT SOME OF THE PROJECTS' STATUS.

#### BY RON NESBITT:

GOOD EVENING. I'M GLAD EVERYONE COULD MAKE IT HERE TONIGHT. BEFORE I GET INTO GIVING YOU AN UPDATE ON WHAT'S BEEN HAPPENING WITH THE PROJECTS AS FAR AS THE YEAR'S CONCERNED AS WELL AS WHAT WE HOPE TO BE ABLE TO DO THE NEXT FISCAL YEAR, I WOULD LIKE TO INTRODUCE SOMEONE TO YOU, OUR NEW D.E. I SAY, NEW; NEW TO YOU. HE'S BEEN WITH US NOW FOR A LITTLE OVER A YEAR. HIS NAME IS COLONEL PETER MUELLER, WHO IS DISTRICT ENGINEER. I WAS ABLE TO PERSUADE HIM TO COME UP TONIGHT EVEN THOUGH HE'S BEEN TRYING TO COME UP TO OUR LAST TWO R.A.B. MEETINGS, BUT HIS SCHEDULE JUST WOULDN'T ALLOW IT. BUT, NONETHELESS, HE'S HERE TONIGHT. COLONEL MUELLER, IF YOU WOULD SAY A FEW WORDS.

# BY COLONEL MUELLER:

I'D JUST LIKE TO SAY A FEW WORDS, AND REALLY I'VE WANTED TO COME UP HERE FOR QUITE SOME TIME AND REALLY APPRECIATE THE OPPORTUNITY TO BE HERE TONIGHT. I JUST WANT TO SAY THANKS TO ALL THE MEMBERS OF THE R.A.B. IT'S A VOLUNTEER THING YOU'RE DOING, AND I'D ALSO LIKE TO THANK THE OTHER PEOPLE THAT ARE HERE TONIGHT BECAUSE IT IS AN IMPORTANT THING FOR US AS REPRESENTATIVES OF THE FEDERAL GOVERNMENT AND CORPS, IS TO BE ABLE TO BE HERE TO GET FEEDBACK FROM EVERYBODY THAT'S HERE BOTH ON THE BOARD AND FROM THE COMMUNITY. I UNDERSTAND THE IMPORTANCE OF WHAT THE FEDERAL GOVERNMENT AND THE ARMY CORPS OF ENGINEERS IS TRYING TO DO HERE FOR THE OLD CAMP CROFT. I UNDERSTAND THE IMPORTANCE TO THE COMMUNITY, AND WE ARE DEFINITELY HERE TO DO EVERYTHING WE CAN FOR YOU. THE ONLY OTHER THING I CAN SAY IS THAT WE'RE ALWAYS FRUSTRATED WITH THE LEVEL OF FUNDING THAT WE GET FOR THINGS LIKE THIS, AND THIS YEAR WILL BE NO EXCEPTION AS THE PRESIDENT IS MAKING HARD DECISIONS ABOUT WHAT GETS FUNDED AND WHAT DOESN'T, AS WE'RE EXPERIENCING WAR ON TERRORISM RIGHT NOW. SO, FUNDING IS ALWAYS AN ISSUE FOR US AS WELL AS FOR THE FOLKS THAT ARE LOOKING FOR PROGRESS HERE. AND, AGAIN, I JUST WANT TO THANK YOU FOR EVERYTHING THAT YOU'RE DOING, ESPECIALLY FOR THE FEEDBACK WE GET FROM MEETINGS LIKE THIS, AND I APPRECIATE YOUR TIME TONIGHT.

TWO THINGS I'D LIKE TO BRING THANK YOU, SIR. TO YOUR ATTENTION. SINCE JANUARY OR FEBRUARY OF THIS YEAR, WE'VE BEEN ABLE TO COMPLETE ONE PARCEL OF PROPERTY, OR I SHOULD SAY ONE AREA, THAT WE'VE BEEN WORKING ON FOR SOME TIME. MOST OF YOU KNOW IT AS THE LANDFILL SITE THAT WE'VE BEEN WORKING ON FOR SOME TIME. THAT IS NOW COMPLETED. BASED UPON FUNDING THIS COMING FISCAL YEAR, OUR PROJECTION FOR WORK TO BE DONE IN THIS AREA IS ACTUALLY NOT VERY IN FACT, THE AMOUNT OF FUNDS THAT WE HAVE FOR THIS AREA DOES NOT AT PRESENT PROJECT ANY MAJOR WORK TAKING PLACE AT THE CAMP CROFT AREA AT ALL THIS YEAR. NOW, WHAT DOES THAT REALLY MEAN? IT MEANS BASED UPON CURRENT BUDGETING, WE HAVE NO FUNDS TO DO ANY WORK. NOW, WE WILL BE ENGAGED IN PROVIDING SOME TRAINING, SOME EDUCATIONAL BROCHURES, ADDITIONAL EDUCATION FOR THE COMMUNITY, TALKING WITH THE NATIONAL PARK SERVICE AT THE STATE PARK AREA, AND DISCUSSING WAYS OF TRYING TO CONTINUE TO GET THE WORD OUT TO THE PUBLIC ABOUT THE SAFETY AND HOW TO RESPOND SHOULD THEY COME ACROSS SOMETHING IN THE PARK AREA OR IN THE AREAS AROUND IT. THAT WILL CONTINUE TO BE DONE, AND SHOULD FUNDS SHOULD COME OUR WAY DURING THE COURSE OF THE YEAR, BE IT AT THE END OF THE FISCAL YEAR OR SOMETIME DURING THE PERIOD, THAT IS SUBSTANTIAL ENOUGH THAT WE CAN GO BACK TO THE SUBDIVISION AND CONTINUE TO REMOVE THE SMALL QUANTITY OF ORDNANCE THAT WE KNOW EXISTS IN THAT AREA THAT WE'VE GOT GUARDED AND PROTECTED; GOLF COURSE AREA THAT HAS ORDNANCE LOCATED IN SOME AREAS THAT WE'VE IDENTIFIED, THAT WE'VE STILL YET TO CLEAR; THESE ARE THE PRIORITIES THAT WE ARE LOOKING AT IN TERMS OF IF FUNDING IS AVAILABLE FOR US AT I CAN SAY TO YOU, SUCH AS WHAT THE THAT GIVEN TIME. COLONEL JUST MENTIONED, WITH THE SITUATION AS IT IS IN TERMS OF MONEY BEING AVAILABLE, MONEY BEING USED FOR OTHER PURPOSES WITHIN THE COUNTRY RIGHT NOW, I'M NOT SAYING THAT THE PRIORITY AS FAR AS WHAT WE ARE DOING IN FUNDS HAS LESSENED; HOWEVER, THE TOUGH DECISIONS ARE BEING MADE, AND THE MONIES ARE BEING USED WHERE THEY FEEL IS MOST NEEDED AT PRESENT. HOPEFULLY, THAT WILL CHANCE IN THE VERY NEAR FUTURE.

WE ARE EXPECTED TO DO BETTER NEXT YEAR AS FAR AS FUNDING LEVELS ARE CONCERNED, AND SHOULD THAT HAPPEN THEN WE HOPE TO BE ABLE TO PROCEED WITH THE AREAS THAT I MENTIONED AS THE PRIORITY SITES RIGHT NOW, TO GET THOSE THINGS TAKEN CARE OF. OKAY. THERE WERE A NUMBER OF QUESTIONS THAT WERE RAISED AT OUR LAST MEETING, AND WHAT I WILL DO IS SUMMARIZE THESE QUESTIONS WITH ANSWERS THAT WE HAVE PROVIDED. QUESTION WAS RAISED REGARDING A CONFLICT OF INTEREST OF SEVERAL MEMBERS SERVING ON THE BOARD. AT<sub>1</sub>T<sub>1</sub> MEMBERS SERVE ON A VOLUNTARY BASIS AS EVERYONE IS AWARE, AND DO NOT RECEIVE ANY COMPENSATION IN ANY WAY, SHAPE OR FORM. THE INDIVIDUAL THAT POSED THE QUESTION HAS GENERALIZED THE SOUTH CAROLINA LAW, AND IN ORDER TO FULLY EVALUATE THE VALIDITY OF THE CONCERN, THE CITATION AS TO THE PRESIDING LAW IN SECTION REFERENCE IS REQUIRED. IN OTHER WORDS, WE HAVE TO HAVE IT IN WRITING SO IT CAN BE FULLY EVALUATED AND DECIDED UPON WHETHER OR NOT THERE IS, IN FACT, A CONFLICT OF INTEREST, WHICH BASED ON WHAT WE'RE DOING, THERE ISN'T ONE. A QUESTION RAISED REGARDING AN AREA IN PACOLET WHERE THE OLD NURSING HOME IS, PLAYGROUND OR GYM THAT IS HIGHLY CONTAMINATED WITH -- HIGHLY CONTAMINATED. AN AREA IN THE PACOLET AREA WAS EVALUATED BASED ON MUSTARD GAS BURIAL. NO EVIDENCE WAS FOUND, AND IN ORDER FOR THE CORPS TO FULLY EVALUATE THE QUESTION, WE NEED IN WRITING THE NAME OF THE NURSING HOME, THE PARK AREA, AND ANY SUSPECTED CONTAMINANTS THAT MIGHT BE IN THAT AREA AS WELL SO IT CAN BE EVALUATED PROPERLY. OUESTIONS REGARDING THE CONTAMINATED WELLS IN THE GLENDALE ROAD AREA, WE STILL HAVE NO REAL EVIDENCE EXACTLY WHERE IT WAS LOCATED. WE'RE STILL UNSURE. THE PREVIOUS CONCERNS REGARDING WELL WATER WERE FOLLOWED UP WITH TESTING BY THE DEPARTMENT OF DHEC. NO CONCERNS WERE NOTED.

FOR A QUESTION REGARDING GERMAN P.O.W. GRAVES, NOT WITHIN PRIVY OF THIS PROGRAM, WHICH WE HAVE SAID BEFORE. MORE APPROPRIATE IDENTITY -- IN FACT, I GUESS, MORE APPROPRIATELY, THE QUESTION SHOULD GO TO THE STATE HISTORIC PRESERVATION OFFICE SINCE WE HAVE NOTHING IN WRITING ABOUT THAT HERE. OKAY. THEY WILL BE MORE IN A POSITION TO DEAL WITH THAT QUESTION THAN WE ARE BECAUSE THAT'S NOT A PART OF WHAT WE ARE HERE TO DEAL WITH.

THE QUESTION REGARDING THE BURIAL TANKS AND TRANSFORMERS, YOU NEED TO CLARIFY THE VEHICLE TANKS OR USTS. EITHER WAY, UNDER THE DIRECT PERVIEW OF

THIS PROGRAM, WE ARE UNCERTAIN WHAT THE QUESTION REALLY ENTAILS, WHETHER IT IS NOT A PART OF THIS PROGRAM OR NOT. WE NEED MORE SPECIFIC GUIDANCE, MORE SPECIFIC DETAILS ABOUT THE QUESTION ITSELF: WHAT TRANSFORMERS, WHERE IT'S LOCATED, AND SO ON.

REGARDING THE R.A.B. TOURS, NEWSLETTERS, AND BROCHURES, THESE DOCUMENTS ARE UPDATED AND PLACED IN AREAS TO BE EVALUATED AND/OR REVIEWED BY EVERYONE IN THE DIFFERENT LOCATIONS, SPECIFICALLY IN THE LIBRARIES, AND SO ON. THE TOUR OF DUTY FOR ANYONE ON THE BOARD HAS BEEN PRESCRIBED, AND, IN FACT, WE HAVE TALKED ABOUT THEM BEFORE. AND, IN FACT, WE'RE IN THE PROCESS, IF I'M NOT MISTAKEN, OF REQUESTING NAMES OF INDIVIDUALS THAT ARE WANTING OR WOULD LIKE TO SERVE ON THE BOARD FOR THE NEXT TERM BASED UPON INDIVIDUALS THAT ARE COMING UP FOR LEAVING THEIR POSITION ON THE BOARD. SO THE OPPORTUNITY FOR ANYONE TO PARTICIPATE AS A PART OF THE BOARD IS AVAILABLE TO ANY AND EVERYONE. YOU DO GO THROUGH AN EVALUATION PROCESS JUST LIKE THEY DID, AND WE WILL HAVE FORMS FOR THAT PURPOSE THIS AFTERNOON, OF WHICH YOU CAN MAKE CERTAIN THAT ZAPATA GETS SO THAT THEY CAN BE EVALUATED AND GO THROUGH THE CORRECT PROCESS.

NOW, THESE ARE THE QUESTIONS THAT WERE RAISED AT THE LAST MEETING, ADDRESSED AT THE LAST MEETING AS WELL, BUT WE FELT THAT THEY NEEDED TO BE CLEARER, MORE CLEARLY IDENTIFIED AND DISCUSSED, OR AT LEAST ANSWERED, THE BEST THAT WE COULD BASED UPON THE INFORMATION WE HAD. HOPEFULLY, I'VE CLARIFIED THAT SOMEWHAT. WE'LL MOVE ON, AND, MR. CHAIR, -- OH, I'M SORRY; SUZY, YOU'RE NEXT.

# BY MS. McKINNEY:

MY NAME IS SUZY McKINNEY WITH ZAPATA ENGINEERING, AND AS EVERYONE IS AWARE, WE PROVIDE THE SUPPORT FOR THE RESTORATION ADVISORY BOARD. BEFORE WE GO TOO FAR DOWN THE ROAD, I WANT TO MAKE SURE THAT ALL THE R.A.B. MEMBERS HAVE SIGNED IN ON THE SIGN-IN SHEET THIS EVENING. I ALSO WANT TO INTRODUCE TWO INDIVIDUALS FROM HUNTSVILLE: BILL STEPHENSON, THE PROJECT MANAGER, AND DAN HUEY, (PHONETIC) THE TECHNICAL MANAGER, U.S. ARMY ENGINEERING SUPPORT CENTER IN HUNTSVILLE. SO, THEY ARE ALSO DIRECTLY INVOLVED WITH THE PROJECT.

AS FAR AS THE RESTORATION ADVISORY BOARD AND OUR TERMS, WE'VE COME TO CLOSURE ON ANOTHER TWO YEARS. SO THE PROCESS AS DEFINED IN THE BYLAWS IS FOR ANY INDIVIDUAL WHO IS INTERESTED TO COMPLETE A FORM. WE HAVE SEVERAL OF THEM TONIGHT AVAILABLE.
