1 BY MR. HAYES:

- I welcome everybody out tonight. I hope everybody is enjoying this
- 3 weather, saving a lot of money on your electrical bills.
- 4 This is the Restoration Advisory Board for the cleanup of munitions at
- 5 the former Camp Croft. To get the meeting started, I'm going to ask Shawn,
- 6 my co-chair, fellow co-chair, to brief everybody about what the RAB is all
- 7 about.

8 BY MR. BOONE:

- 9 As Gary said, my name is Shawn Boone. I work for the Army Corps of
- 10 Engineers.
- 11 As many of you may know, Camp Croft was an infantry training base
- during World War II, and, in 1947, they stopped operations there and turned
- 13 the land back over to other landholders.
- This project, the Corps of Engineers' project at the former Camp Croft
- 15 is specifically about contamination that was laid down during that time frame,
- during World War II, and not about any current pollution issues that may be
- 17 resulting from current operations.
- So, I know there have been a lot of press and some complaints to DHEC
- 19 and EPA lately about some ground water issues associated with some
- 20 manufacturing in the area. So if you're here about that, we'll try to answer the
- 21 questions as best we can, but mostly and specifically this meeting is about the
- 22 former Camp Croft, the infantry training base, so just to let you all know.

23 BY MR. HAYES:

- 24 Okay.
- We want to get into new business now.

- 1 We'll have a project update by the United States Army Corps of 2 Engineers. BY MR. BOONE: 3 So there's no real project update. We've entered a new fiscal year. 4 Federal fiscal year runs from October 1st to September 30th, and so we didn't 5 6 receive funding this fiscal year to do any removal of the anomalies we identified 7 in the geophysical investigation. However, it is scheduled for 2011, the next 8 fiscal year; and if there's any extra money nationwide, we're hoping to be able 9 to provide for that and get some work done. 10 We did, however, award a three-year contract to Zapata to facilitate 11 this RAB, and so they'll be with us for that duration. 12 BY MR. HAYES: 13 Okay. Next on our agenda, the Sheriff's Department munitions response. 14 Lieutenant Dyas, do you have anything to report? 15 BY LIEUTENANT DYAS: 16 We haven't had any --- we haven't been very busy regarding the Camp 17 Croft area. We do have a new certified tech that just got back, so now we have 18 four certified techs at the Sheriff's Office that can respond. 19 We have --- we respond in teams of two, so we have to have two teams, 20 well, two that we can respond to anywhere throughout the county or anywhere 21 we need to respond, so we are --- we've got some more equipment coming in so 22 that we --- each team can have enough equipment to respond to wherever we 23 have to respond down in that area. So we're covered 24/7, so we're good now.
- 24 BY MR. HAYES:
- Okay, and to report munitions just dial 911.

1 BY LIEUTENANT DYAS:

- 2 Yes.
- 3 BY MR. HAYES:
- 4 All right.
- 5 Anybody have any questions from the Sheriff's Department?
- 6 (NO RESPONSE)
- 7 BY MR. HAYES:
- 8 Okay. Our next on our agenda will be community outreach tools. It will
- 9 be by the United States Army Corps of Engineers.
- 10 BY MR. BOONE:
- 11 The last time we met we spoke with the RAB about some different
- options to educate the public about our project, and we had a presentation by
- our public affairs officer that sort of gave an overview of different strategies
- 14 for reaching out to the public and educating people about our project; and so
- 15 the take away from the last meeting was that we would come back with some
- specific examples of some things that we had talked about, specifically
- 17 brochures and some other tools to reach out to different audiences.
- So, Glenn Jeffries is here, and she's put together just some examples of
- 19 different tools here. There is this tri-fold brochure. You want to pass those
- 20 down that way, and then there's a more traditional type of fact sheet that we
- 21 could produce to educate people about the project; and actually Zapata has
- 22 produced one here for everybody, you guys can get them, that tells specifically
- about the Camp Croft project; and then, Glenn, if you want to address some of
- 24 the other issues.
- 25 BY MS. JEFFRIES:

We talked about different audiences and things we could use while talking to different audiences; and if we decide that we do want to go into some of the schools, we talked about getting Sergeant Woofy to come in costume.

We have these kind of fliers that we could display that relate that the elementary kids relate to very well. We also have these coloring books that we could have put together that sort of explain and talk about the three Rs, which is recognize, retreat and report, and we know that's the main message that we want to get across to the public that if you see something and you don't recognize it, don't pick it up. Recognize, retreat from it immediately and report, call 911, and they'll handle it.

So that's the main message we want to get out to the community and there's just a lot of different ways that we can do it, and these fact sheets are just some of the ways; and last time we looked at the video. We talked about that.

I think --- and we talked about just trying to get attendance at the meetings. We have that tonight, so that's great, and I think we can get our message out that way.

It's really a decision that you all need to make about what direction you want to go in, and Shawn and I are happy to help you once you decide.

20 BY MR. HAYES:

Okay. Does anybody have any questions about the community outreach?

22 Discussion?

23 BY MS. CANTOR-MCKINNEY:

We may want to open it to the board to get some of ---

25 BY MR. HAYES:

1 Well, I asked if anybody's got anything to add or questions or any 2 discussion. 3 (NO RESPONSE) 4 BY MR. HAYES: 5 Okay. So the next on the agenda is old business, OOU12B EE/CA 6 findings. This will be by the Army Corps of Engineers. 7 BY MS. CANTOR-MCKINNEY: 8 A question was raised at the last meeting about the status and the 9 findings of an area of investigation during the EE/CA, 00U12B, and we just 10 wanted to follow up with that to that question. 11 That area of investigation was comprised of four 50 foot by 50 foot 12 grids. The area, and we have a map that we can point to here shortly if anyone 13 is interested specifically in looking at where that location is, there was some 14 right-of-entry issues, some rights-of-entries were denied, so that the entire 15 area was not fully investigated, hence the four 50 by 50 foot grids. 16 During that investigation, one UXO was found. It was an M9 rifle 17 grenade. It was found at four inches. No other fragmentation was found. No 18 other munitions debris was found during that investigation. The recommendation for OOU12B is clearance for use. 19 20 BY MR. HAYES: 21 Well, I was the one that brought this matter up, and I have a lease on 22 this property myself, and I brought it up in the last two meetings, the one in 23 January and one in June, and at that time I stated that we were going to be

logging pulpwood out of there and also stated that the loggers were bringing in

logging machinery, and on their rubber tires they put chains on the tires to

24

1 make sure they didn't get stuck and get extra traction; and it was a hazard, if 2 there was munitions in there, that spinning the tires or even just going over a 3 piece of ground where something might have worked up to the top would be a 4 hazard to anyone around operating machinery or next to machinery. 5 So I asked at the last two meetings, I've asked Zapata and the Corps of 6 Engineers to let me know what the status of this was, and I haven't heard 7 anything until tonight. Our logging began in July, and so this is a little bit too 8 late; and like anybody else in here, if you ask somebody for something, 9 information, especially since January, one month, two months, three months 10 might be enough time, but from January to November I think is in excess, 11 especially when I stated that the logging would be starting soon, especially in 12 June I said the logging would be starting next month, and it's --- I don't know 13 what the holdup was, and there's got to be some kind of explanations, and 14 there's got to be something that comes about that if any one of you in here has 15 a problem, you should be able to get a response back from somebody if you ask 16 something, and I think it's only right for landowners to get something if 17 somebody is saying there's a problem, they should get some response back. 18 So, I'd like to read part of a Minutes which was from --- from a former RAB meeting, and this is back in September 9th, 1997. 19 20 The former fire chief at the Croft Fire Department, David Mullinax, was 21 the chairman of the board then. 22 He says, "Okay. I passed out a piece of paper. This is a little topic on my agenda that was in the July 26th Herald-Journal Upstate, page B-1." 23 24 Okay. This is from the September 9th, 1997, meeting.

This is the *Herald-Journal Upstate*, page B-1.

"This happened on Friday, July 25th. Those of you who did not read the 1 2 article, these kids found a grenade in a creek off of Cedar Springs Drive. I'm 3 going to say Robin Hood. It's not Robin Hood. Friar Tuck. It was Friar Tuck 4 into where the power lines go through the State Park. Now it was in the creek. These boys found it on Friday, the 18th. It was reported to the Sheriff's 5 6 Department on the 25th." Okay. That's the 18th to the 25th. 7 "That is a week after the grenade was found. We have two gentlemen in 8 9 the room right now that knew about it when it was found and did absolutely 10 nothing about it. One of them is a member of the board, Mr. Osborne. The 11 other one, Mr. McCain, and I'm appalled that when it happened that neither one 12 of the gentleman contacted anybody on this board, the Sheriff's Department, 13 the Fire Department, the Rescue Squad, the Army, Zapata, nothing. Nobody 14 was contacted." 15 "You all can read the article. It's right here in black and white. Gary 16 Henderson has the photos to prove it." 17 Gary Henderson worked with the newspaper. 18 Mr. Littlejohn to my right said, "Mr. Chairman." 19 Okay. 20 "By Mr. Mullinax: Yes, sir." 21 Okay. Mr. Littlejohn to my right. "In looking at the article and some 22 other things that have come to light, it seems that one of our roles here on the 23 board is to serve as a conduit for the flow of information to and from the 24 community; and we have members of the community placing their trust in us as 25 members of the RAB, who we've identified ourselves as members of the RAB,

- 1 and we violate that trust, then I feel that that also is a violation of our By-
- 2 Laws."
- 3 "Under Section J, it says, 'A RAB member may be removed from the RAB
- 4 by a majority vote if it is determined that the actions of the individual are not
- 5 in the best interest of the RAB."
- 6 "Endangering lives of the citizens of our community, much less a child, is
- 7 certainly not in the best interest of this RAB, and I'd like to put it in the form
- 8 of a motion that we terminate Mr. Osborne's relationship with the board."
- 9 Mr. George Mullinax, who is also a member of this board now, he's not
- 10 here tonight, seconded the motion.
- I think this correlates with what happened with this on OOU12B. You
- 12 know it's the same thing. They had information about something that's out
- 13 there but don't come forward with the information. I think it's very un-
- 14 excusable, and I'd like some discussion with the board to see what they think
- 15 about this.

16 BY MR. BOONE:

- 17 First of all, I'd like to say that it was my responsibility to answer that
- inquiry, and I take full responsibility for not answering that inquiry, and I'm
- 19 sorry that it wasn't in a timely fashion.
- I misunderstood the requirement and the time frame of your work to be
- 21 done out there, and I apologize.
- Now, also, everything that we know about this project is out on the
- 23 website and all the documentation is there. Additionally, I handed out my
- 24 contact information, email address, phone number, and anybody here is welcome
- to call me at anytime and remind me of their agenda.

1 I apologize.

BY MR. HAYES:

- Okay. When it comes to the right of entry, there hasn't been any problem with the right of entry, Suzy. The right of entry was signed. It hasn't been deleted. It hasn't been cancelled, and they've already been in there. They were in there the first part of 1990, and these trees were planted back then. They were like yearlings when they went in there, and now that we're just now harvesting.
- So, I don't know, this is --- you know, we want to try to go out into the public and say, "Let's do the community outreach. We've got to teach people the dangers," but then, on the other hand, when you ask for things, questions about what's going on or what, they just said, "Well, just give me coordinates of where it is. I can tell the loggers to stay away from this area," but I don't get anything, and I can't tell the loggers anything.
- So, you know, it's just kind of --- you know, when you have to approach the logger and say, "Well, you're on your own because we asked for information. We just it's, you know, if you get hurt, it's up to you," so I think it's just really disappointing that things were like they were.
- All right. Now new business topics. We have a lot of people in the public now. Does somebody have something they'd like to bring up?

21 BY MS. SAMUEL:

Excuse me. My name is Pam Samuel, and I came in late on the part of what you was saying about this is just for the bombs and things that you all was talking about, so this doesn't have anything to do with the tanks that's in the Pine Ridge area and various areas? It doesn't have anything to do with that?

1 BY MR. BOONE: 2 No, ma'am. 3 BY MS. SAMUEL: This is my first time at the meeting in the area. It was told to me that 4 5 this was the meeting to come and talk about the tanks, but it's not? 6 BY MR. BOONE: 7 No, ma'am, it's not. This meeting is about the Army Corps of Engineers' 8 project associated with the former infantry training base at Camp Croft, what 9 used to be Camp Croft. 10 BY MS. SAMUEL: 11 Okay. Oh, okay. I just wanted to make sure. 12 Thank you. 13 BY MR. HAYES: 14 Are the gas tanks on the former Camp Croft? 15 BY MS. SAMUEL: 16 Excuse me? 17 BY MR. HAYES: 18 Are the gas tanks on the former Camp Croft? 19 BY MS. SAMUEL: 20 Yes, they are. 21 It's just gas tanks everywhere in the area, and it's just terrible. You 22 know, from my understanding I thought we was here for, you know, the 23 appearance of the tanks and just various things that was happening there in the 24 Pine Ridge area and other places as well.

25

BY MR. HAYES:

- 1 Okay. Do you have evidence of what led you all to believe what you 2 believe or what you thought the meeting was about? 3 BY MS. SAMUEL: 4 Well, it was told to me when a guy in our backyard just recently had one, 5 and there was a meeting about, you know, the tanks, and if you have anything to 6 say about them or, you know, the appearance of it, that we have that right to 7 come, you know, and talk to you all about it. 8 BY MR. HAYES: 9 Yes. Well, I think a lot of those tanks were constructed --- you're 10 talking about the oil tanks over there? 11 BY MS. SAMUEL: 12 Oil, yes. Uh-huh (affirmative response). 13 BY MR. HAYES: 14 The gas tanks. I think most of those were constructed after the camp. 15 It might be on the former camp property, but I think most of those were 16 constructed after the camp. 17 BY GENTLEMAN IN THE AUDIENCE: 18 Well, does it have to do with the water? 19 BY MR. BOONE: 20 No, sir. 21 BY GENTLEMAN IN THE AUDIENCE: 22 Well, I'm at the wrong place then. 23 BY MR. HAYES: 24 Okay. Sir, can you state your name for a record?
- 25 BY GENTLEMAN IN THE AUDIENCE:

1 (Inaudible). 2 BY MR. HAYES: 3 Okay. Yes, ma'am. 4 BY MS. WILLIAMS: 5 Good afternoon. My name is Gloria Williams, and I, too, live in that ---6 having lived in that area before. As a child, I grew up in that particular area 7 that Pamela Samuel was referencing talking about, and actually those tanks has 8 been there many, many, many years. My mom and my dad, they also have been 9 there numerous of years. So we grew up in that particular area. 10 Several years back we had a spill, and it was a very big spill down in that 11 area. There was a leakage. Does anyone remember that? 12 BY MS. SAMUEL: 13 Quite a few. 14 BY MS. WILLIAMS: 15 Yes, it was a leakage from that from the tanks, and we had to evacuate 16 down to the Mt. Sinai Baptist Church. 17 BY MR. HAYES: 18 Do you all live up the hill from Mt. Sinai? 19 BY MS. WILLIAMS: 20 Uh-huh (affirmative response), up the hill. I lived right in the vicinity ---21 BY MR. HAYES: 22 Yeah. Uh-huh (affirmative response). 23 BY MS. WILLIAMS: 24 --- of the tanks, you know, and my concern tonight is, I might not be at 25 the right meeting, but I'm going to say this because my concern is that over the

- 1 years that we have lived in that area, we have drank well water. So we know
- 2 there are some seepage from there from the previous years, and my concern is
- 3 that the health of myself, my children, my mom, my dad, and all of the
- 4 neighbors that have lived in that area.
- 5 BY MS. SAMUEL:
- 6 Exactly.
- 7 BY MS. WILLIAMS:
- 8 And my question is where do you get this information from? Who do you
- 9 talk to in reference to that?
- 10 BY MS. SAMUEL:
- 11 Exactly.
- 12 BY MS. WILLIAMS:
- 13 This may be the wrong meeting tonight.
- 14 BY MS. SAMUEL:
- 15 That's right.
- 16 BY MS. WILLIAMS:
- 17 I'm sure it is.
- 18 BY MS. SAMUEL:
- 19 Uh-huh (affirmative response).
- 20 BY MS. WILLIAMS:
- 21 But my concern is that there's someone that I know that we can talk to in
- 22 reference to that.
- 23 BY MS. SAMUEL:
- Right.
- 25 BY MS. WILLIAMS:

1 Am I right about it? 2 BY MS. SAMUEL: 3 That's right. 4 BY MS. WILLIAMS: 5 Okay. All right. 6 BY MS. SAMUEL: 7 Don't doubt about it. 8 BY MS. WILLIAMS: 9 Okay. All right, and as you --- and as you said earlier, if you state 10 something and you put a question out there, we --- we expect an answer. 11 BY MS. SAMUEL: 12 And I agree with you. 13 BY MS. WILLIAMS: 14 Yeah, and so that's what I'm just saying, you know, because I drink that 15 water, and I'm 54 years old now, so I drink that water many, many, many years. We even had gardens back in those days, and we had well water, and those 16 17 tanks were there then, and that's 54 years. 18 BY MS. SAMUEL: 19 Uh-huh (affirmative response). 20 BY MS. WILLIAMS: 21 I'm 54, so my mom and dad, they're my parents, and you know they're 22 much --- my mom is 75 years old. 23 BY MS. SAMUEL: 24 Right. 25 BY MS. WILLIAMS:

- So those tanks has been there lots of time --- a long time. I lived in the
- 2 Huntingwood's area for numerous of years myself when I moved out from my
- 3 mom. So I've been in that area all my life. All my life I've been in that area,
- 4 which it is a good area. It's a good growing area.
- 5 BY MS. SAMUEL:
- 6 Right.
- 7 BY MS. WILLIAMS:
- 8 My concern is I know that there has been a lot of people that has passed
- 9 on, my father, my aunts, my uncles, due to some of those leakage of those
- 10 tanks, those fumes that we have inhaled over the years.
- 11 BY MS. SAMUEL:
- 12 That's right.
- 13 BY MS. WILLIAMS:
- 14 That's my concern. So if you, if anyone on the panel has any information
- 15 who we need to talk to in reference to that, we would --- we would like to know
- 16 that information.
- 17 BY MR. SCATURO:
- 18 I ---
- 19 BY MS. WILLIAMS:
- 20 Yes, sir.
- 21 BY MR. SCATURO:
- 22 I work for DHEC.
- 23 BY MS. WILLIAMS:
- 24 Okay.

- The last --- the problem I have been having the last six months there's a
- 2 strong foul odor.

- 16 but what I've seen is that right up here, it's not Ashley, but it's another oil
- 17 company, they have taken up a whole lot of stuff out of the ground; and I don't
- 18 know if that foul odor is coming out of the ground, but at night around two,
- 19 three, four o'clock in the morning that odor is rotten. It's around it's all over.
- 20 It's such a strong foul odor, and I called DHEC, and they were supposed to
- 21 return my call because she knew exactly what I was talking about and no one
- 22 has gotten back in touch with me, and that was my concern, and my name is
- 23 Sheila Jenkins.
- 24 BY MR. SCATURO:
- Do you know who it was at DHEC you talked to?

- 1 BY MS. JENKINS: 2 It was a young lady. I got the name at home. 3 BY MR. SCATURO: 4 Cindy Parton {phonetic spelling}. 5 BY MS. JENKINS: 6 That's exactly right. That's it exactly. She said that she understood 7 what I said, and that there was a couple of more complaints that had came 8 through, and she --- but she hasn't returned my call. 9 BY MR. HAYES: 10 Thank you, Ms. Jenkins. 11 Robin, you had something to add? 12 BY MR. ZIMMERMAN: Just for the history. In 1941 before that camp was built, the defense 13 14 pipeline from Baton Rouge, Louisiana to Fairfax, Virginia was run through Camp 15 Croft, and there were a large number of oil tanks out there, including two 16 underground half million gallon tanks that still exist out there in the Plantation 17 Pipeline, and those private oil companies took those tanks over at the end of the 18 war. In fact, that was in 1946. 19 There's currently nine oil companies out there. There's a lawsuit, which 20 James Lancaster and a number of these people in here filed against all nine oil 21 companies. That's probably why most of these people are doing here tonight. 22 That's how they thought it tied in with Camp Croft. 23 BY MR. HAYES: 24 Where are the underground tanks?
- 25 BY MR. ZIMMERMAN:

- 1 As you go down Union Street coming from, say, coming from where the
- 2 old depot used to be where Plantation Pipeline used to be, the one that sits
- 3 right in front or outside the railroad, and another one is about 50 yards back.
- 4 In fact, in 1973, when they had that oil embargo, Plantation Pipeline was
- 5 able to dip into those tanks and extract fuel after all those years. It was still
- 6 there, and ---
- 7 BY MR. HAYES:
- 8 If ---
- 9 BY MR. ZIMMERMAN:
- 10 --- I've got photographs, though. I'll be happy to show any of these
- 11 people in here to show that they did exist during the camps here.
- 12 BY MR. HAYES:
- So you go past Clement Lumber Company. It's down on the --- the tanks
- 14 are down on the left?
- 15 BY MR. ZIMMERMAN:
- 16 Yeah.
- 17 BY MR. LITTLEJOHN:
- And --- but, Robin, let me make sure I understand, on that side of the
- 19 road that was not part of the camp.
- 20 BY MR. ZIMMERMAN:

- 4 travesty down in that area, but only for my family, but --- but numerous of
- 5 families for miles away that lives in that area. That's terrible, so we need to
- 6 really get on --- onto this guick, fast and in a hurry, because we don't know what
- 7 tomorrow is going to bring. Am I right, sir?

- 3 tabletop exercises in regard to those tanks either exploding, catching fire, or
- 4 even the chemical company down there, we've done tabletop exercises, what to
- 5 do in those type of situations either shelter in place or evacuation, and we
- 6 looked at the different types of evacuations. We've looked at how quickly we
- 7 could actually do that.
- 8 We've actually have gone out and taken a step further and actually gone
- 9 out and done exercises regarding that. So we're trying to be prepared for
- 10 what you're talking about, and I just wanted to put you at a little bit of ease on
- 11 that, that we also think, and this is Spartanburg County Council along with that,
- also, because they take what we do, as far as the Hazmat team is concerned, so
- 13 there's a lot of --- lot of officers that volunteer their time to come out and
- 14 train and get prepared for any type of incident like that that might take place.
- 15 We are looking at that. We do see that as a problem down there, and one of
- 16 the bigger problems in Spartanburg County.
- 17 BY MS. WILLIAMS:
- Thank you so very kindly. Thank you for that information. Thank you.
- 19 BY MR. HAYES:
- Okay, buddy, you've got something you want to add?
- 21 (NO RESPONSE)
- 22 BY MR. HAYES:
- Oh, I thought he had his hand up.
- Okay. Does anybody else have anymore discussion, anything you'd like to
- 25 add?

1 BY MS. WILLIAMS: I will say goodnight. Thank you all. 2 3 BY MR. HAYES: 4 Thank you, Ms. Williams. 5 BY MS. WILLIAMS: 6 Thank you so very kindly. 7 BY MR. HAYES: Board, do you have anything else you want to discuss? You want ---8 9 anything, new topics you want to bring up at the next meeting? 10 BY MR. TOBIAS: 11 So what they've said, Gary, is there's no funding this year but there may be funding for next year to work off some of the designated areas? 12 13 BY MR. BOONE: 14 It's in the life cycle plan to fund the work next year, yes. 15 BY MR. TOBIAS: Do you think it will actually get funding? 16 17 BY MR. BOONE: 18 Yes. BY MR. TOBIAS: 19 20 Really? 21 BY MR. Between 2004 and 2008

a munitions removal was conducted on approximately eleven acres of the OOU3 expanded area in and adjacent to Wedgewood. Zapata Incorporated, under contract to the U.S. Army Corps of Engineers, removed 34 live munitions and explosives of concern (MEC) and 722 pounds of munitions debris during the removal effort that encompassed two brief field sessions (fall – winter 2004 and fall – winter 2005). Digital geophysical mapping was conducted in additional areas of the OOU3 expanded area and in OOU11 in 2007 – 2008.





EE/CA Process

Engineering Evaluation/Cost Analyses (EE/CA) Process

An EE/CA identifies munitions concerns, current and proposed land use, and presents risk reduction alternatives with estimated costs for each area of concern.

The initial phase of an EE/CA may include the collection of geophysical data which is used to identify subsurface metallic objects.

Data processing allows project personnel to select items that are the size of potential munitions item for intrusive





Intrusive investigations, or subsurface sampling, verify what is underground. Based on the past land use, items may include wire, household debris, or military munitions.

These data are evaluated and a risk analysis is conducted as part of the EE/CA.

Several risk reduction alternatives are considered in an EE/CA:

- No Department of Defense Action Indicated
- Surface clearance
- Clearance to depth
- Institutional controls (public education, fencing, land use restrictions)
- Combination of alternatives

The EE/CA document is available for review under a formal Public Comment Period. During this time, the document is available at the designated Information Repository.

At the conclusion of the Public Comment Period, the document is finalized, with a Responsiveness Summary written to address comments received.

An Action Memorandum, or decision document, specifies the selected risk reduction alternatives, and is signed by the US Army Corps of Engineers.




