1.0 OVERVIEW OF THE COMMUNITY RELATIONS PLAN

a. The U.S. Army Corps of Engineers (USACE) has developed this Community Relations Plan (CRP) to facilitate two-way communication between the USACE and communities surrounding the former Camp Croft, a formerly used defense site (FUDS) located in Spartanburg County, South Carolina (SC). The USACE will use the community involvement activities outlined in this CRP to ensure that community members are continuously informed about the provided opportunities to be involved in the environmental restoration process at the former Camp Croft. Appropriate and effective communication and the timely exchange of information are imperative for maintaining community understanding and support for restoration activities and ensuring the success of this CRP.

b. The CRP was specifically developed to support the Camp Croft Restoration Advisory Board in accordance with Engineer Pamphlet (EP) 200-3-1, Public Participation Requirements for Defense Environmental Restoration Program (DERP). The former Camp Croft includes discrete locations known to require further action to address explosives safety, human health, and environmental risks presented by munitions hazards. The USACE has and will continue to execute the public involvement activities outlined in this plan to ensure that stakeholders are provided with information essential to their understanding of USACE activities, and are given the opportunity to provide input during the decision-making process regarding future USACE activities at the former Camp Croft.

c. This section presents an overview of the CRP. Section 2 provides a site history and a description and overview of activities that have occurred at the site. Section 3 provides a community profile and a history of community relations. Section 4 describes the projected activities intended to respond to community concerns and communication needs. Section 5 lists applicable references. A community survey, meeting locations, and contact lists are provided in the appendices.

2.0 SITE DESCRIPTION AND HISTORY

2.1 PROPERTY HISTORY

a. On November 4, 1940, the War Department announced that a new training center would be located in Spartanburg County, SC. Camp Croft Infantry Replacement Training Center (IRTC) was officially activated on Jan. 10, 1941, with housing for 20,000 trainees and support personnel. Camp Croft IRTC consisted of two general areas: a series of firing ranges and a troop housing area with attached administrative headquarters. Camp Croft IRTC served as one of the Army's principal IRTCs where approximately 250,000 Soldiers were trained. Camp Croft was also a prisoner of war camp during World War II. The installation was declared surplus to the Army's needs in November 1946 and excessed to the War Assets Administration in 1947. The site is now a mix of residential, recreational, light industry, and commercial use.

b. The former Camp Croft was used for a variety of different purposes. It had at least 11 live ammunition-training ranges used for small arms ammunition, anti-tank rockets, anti-aircraft artillery, 60 millimeter (mm) infantry mortars, and 81 mm infantry mortars. The training range impact areas comprised a total of 16,929 acres.

2.1.1 Munitions and Explosives of Concern (MEC)

a. Based on information in the Archives Search Report (ASR), site investigations and remedial actions, and removal actions, MEC specific to the site consists of mortars, grenades, and projectiles. The following list includes MEC recovered from the former camp:

- Mk I and Mk II hand grenades,
- M15 hand grenades,
- M19 rifle grenades,
- M1 anti-tank mine,
- 60mm and 81mm mortars,
- 37mm, 57mm, 105mm illumination projectiles; and
- 2.36-inch rockets.

2.1.2 Munitions Constituents

a. Explosive components as a munitions constituent (MC) are highly unlikely to be present at concentrations that pose a risk to human health and the environment. Based on the MC analytical results, the risk assessments concluded that the potential for adverse risks to human health or ecological receptors from exposure to MC is negligible at the former Camp Croft.

2.1.3 USACE Involvement

a. The USACE verified that the property was FUDS-eligible in a November 1991 Findings of Fact Memorandum.

2.1.4 Community Reaction

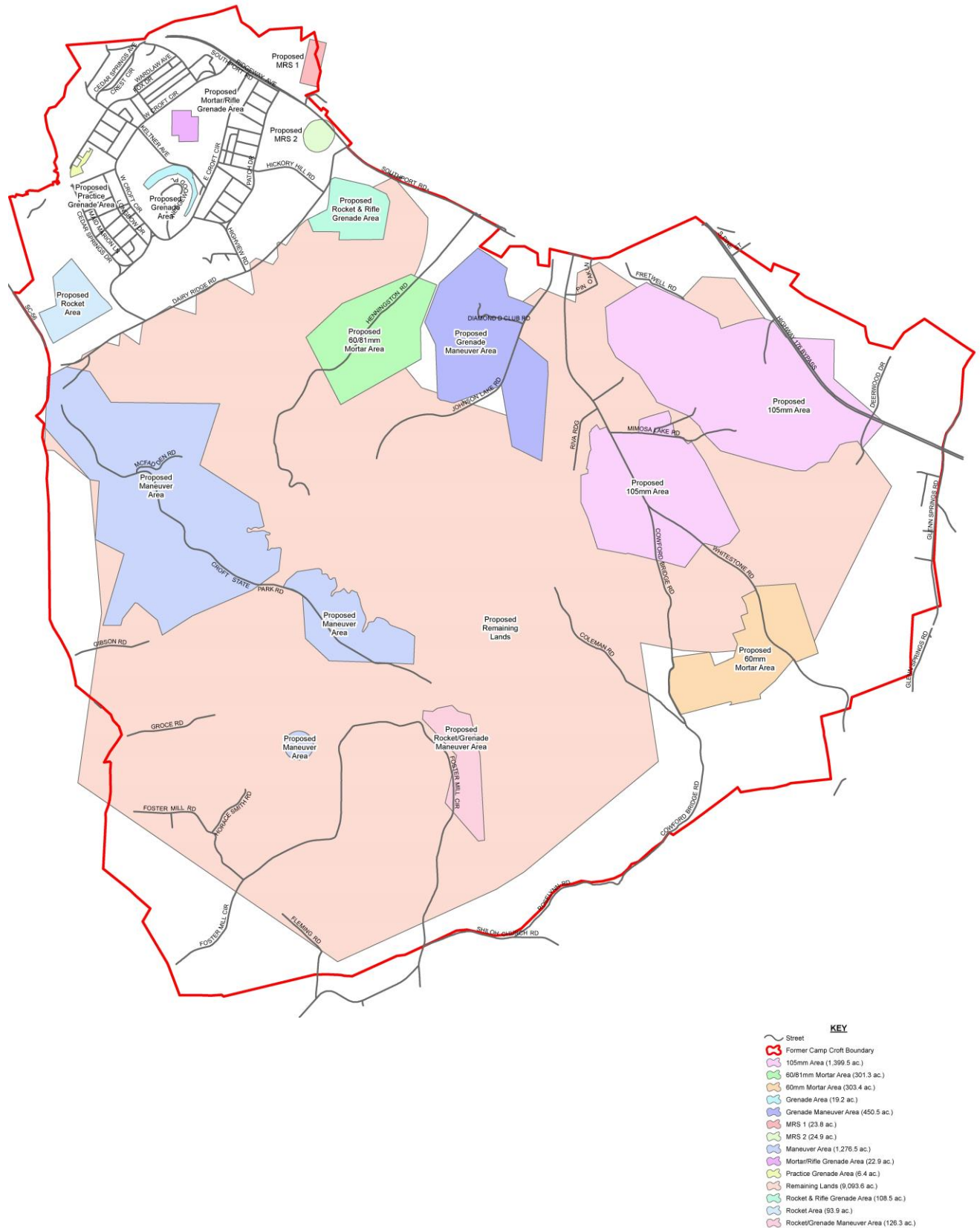
a. The community has been actively involved with munitions response activities since 1996 with establishment of the Restoration Advisory Board. In addition, stakeholders have participated in Technical Project Planning (TPP) meetings during the Remedial Investigation/Feasibility Study RI/FS).

2.2 LOCATION AND PHYSICAL DESCRIPTION

a. The former Camp Croft is located in the upstate of South Carolina, less than 10 miles southeast of downtown Spartanburg, SC. The site is roughly bound to the north by SC Highway 295, to the east by US Highway 176, to the south by SC Highway 150 and to the west by SC Highway 56. The site can be accessed by taking US Highway 176 south at Exit 72 along US Interstate 85.

b. The former Camp Croft occupies approximately 19,044 acres, the majority of which includes Croft State Natural Area. Much of the land is wooded. The highest elevation is approximately 800 ft above mean sea level and topography varies only by several hundred feet. There are two man-made lakes within Croft State Natural Area; Lake Johnson and Lake Craig. The remainder of the area is a mix of residential, light industrial, and commercial use. Figure 2-1 is a Site Layout map of Former Camp Croft.

2.3 PROPERTY INSPECTIONS AND CLEANUP ACTIVITIES

a. The following munitions response (MR) activities have occurred since the inception of the Community Relations Program at the former Camp Croft 1996. Two Engineering Evaluations/Cost Analyses (EE/CA) and an RI/FS have been completed for the former Camp Croft. Areas of investigation are divided into smaller, manageable areas referred to as ordnance operable units (OOUs), munitions response sites (MRS), or Areas of Potential Interest (AoPI). Munitions removal has occurred at OOU3, OOU6, and OOU7 per the recommendations of the EE/CA and subsequent Action Memoranda; an interim removal action was completed on 50 acres south and east of Dairy Ridge Road, just west of Southport Road in 2013.

2.4 PREVIOUS INVESTIGATIONS

2.4.1 Inventory Project Report (INPR)

a. The USACE verified that the property was FUDS-eligible in a November 1991 Findings of Fact Memorandum.

2.4.2 Archives Search Report (September 1993)

a. The 1993 ASR was prepared by the Corps of Engineers, Rock Island District to evaluate the potential for MEC. The ASR compiles information obtained through historical research at various archives and records-holding facilities, aerial photography review, interviews with persons associated with the site, and a site inspection. All efforts were directed at determining the possible use or disposal of ordnance on the site. A Supplemental ASR was prepared in 1996.

2.4.3 Engineering Evaluation/Cost Analysis (EE/CA)

a. Two EE/CAs have been prepared, one in 1996 and one in 1998.

2.4.4 Remedial Investigation

a. An RI was conducted in 2012 to characterize the nature and extent of munitions and explosives of concern (MEC) and munitions constituents (MC), and to perform an ecological and human health risk assessment to support developing and evaluating effective remedial alternatives in the Feasibility Study.

2.4.5 Lead Agency

a. This CRP was based on guidance for Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA), 42 U.S.C. §9601 to §9675 remediation activities, as implemented by the National Oil and Hazardous Substances Pollution Contingency Plan (NCP) (40 Code of Federal Regulations (CFR) Part 300).

b. The USACE is the lead agency for the munitions response actions at the former Camp Croft, with regulatory oversight provided by the South Carolina Department of Health and Environmental Control (SC DHEC).

3.0 COMMUNITY BACKGROUND

3.1 COMMUNITY PROFILE

a. The area known as Spartanburg County was formed in 1730 when a treaty marking the boundary between the province of South Carolina and the Cherokee Nation was signed. Today the boundary separates Spartanburg and Greenville Counties. The U.S. Bureau of Census 2015 population estimate is 297,302 people residing in Spartanburg County. The estimated racial makeup of the county was 74.5 percent White, 21 percent Black or African American, 0.4 percent American Indian and Alaskan Native, 2.3 percent Asian, 0.1 percent Native Hawaiian and Other Pacific Islander, and 1.7 percent Two or More Races. Hispanic or Latino of any race represented 6.4 percent of the population (USCB, 2015).

b. Spartanburg County had 108,383 households reported between 2010 and 2014. The population is comprised of 23.7 percent under the age of 18, and 15.1 percent 65 years of age or older. The female population makes up 51.5 percent of the total population. The 2015 Census survey estimates that 61.3% of the civilian labor force is employed. The median household income was \$43,555 and 17.7 percent of the population was estimated to be below the poverty level in 2010-2014 (USCB, 2015).

3.2 CHRONOLOGY OF COMMUNITY INVOLVEMENT

a. In 1995, telephone surveys of local residents were conducted in an effort to determine the level of knowledge and interest in the munitions response activities underway at the former Camp Croft. Residents were also informed of the opportunity to become involved in the RAB. Telephone calls were made during the day as well as early evening hours. Ninety eight calls were made; 44 individuals participated in the interview.

b. A project-specific public Open House was held on June 8, 1995. Thirteen individuals signed the attendance sheet. The issuance of fact sheets and news releases, and conducting telephone interviews with members of the community have served to increase the awareness of the removal activities and the objectives of the RAB. Fourteen individuals signed the attendance sheet at the Oct. 24, 1995 Open House. A RAB was established in late 1995. In addition to the 18 RAB members, 17 private citizens attended the first RAB meeting on Jan.16, 1996.

c. The RAB has been active since its inception. The term of each RAB is two years, and RAB membership is four. Average public attendance at the RAB meetings is 10-15 individuals. All RAB meetings are open to the public and announced via mailed note cards to the more than 550 individuals on the mailing list, by display advertisements in the *Spartanburg Herald Journal*, and on the website. In addition, a public meeting to present the Proposed Plan describing remedial action alternatives was held on March 24, 2016.

3.2.1.2 Mailings/Mailing List

- a. The contact lists included in Appendices have been incorporated into the project mailing list. The current mailing list is dynamic and is continually updated based on meeting attendees and mailings that have been returned as undeliverable. The current mailing list includes more than 550 addresses.

3.3 COMMUNITY INTERESTS AND CONCERNS

- a. Over the last 15 years, community issues/concerns have focused on the length of time required to complete munitions response actions due to funding constraints. Property owners have expressed frustration that USACE revisits the same parcels several times before a clearance is complete. In addition, individuals attending the RAB meetings have identified areas of

concern beyond those identified in the EE/CA and RI documents that they would like to see addressed. Concerns identified range from anecdotal information to confirmed MEC finds/responses by the Spartanburg County Sheriff's Department.

4.0 PUBLIC INVOLVEMENT PROGRAM

a. The goal of this plan is to provide an effective and operational mechanism for communication and exchange of information between the USACE, stakeholders, and diverse federal, state, county and local agencies. As the USACE is committed to being open and transparent in its decision-making process, it will involve and solicit input from the community. It will be proactive and contact the community and share information in a variety of ways, such as public meetings and the distribution of informational materials. The ultimate objective is to provide useful information in a form that is understandable and accessible to the community via avenues perceived as credible.

b. To achieve these goals, several approaches will be employed as standard practices whenever reasonable, including the following:

- Proactively make contact with the community and its members
- Disseminate information to the community using a combination of tools
- Tailor information to make it understandable and relevant

4.1.1 KEY MESSAGES

a. To best communicate with the community, the convictions that underlie USACE environmental remediation programs will be incorporated into public involvement efforts. Information on issues such as environmental contamination and remediation will be disseminated to a variety of audiences to facilitate these communications. The following messages will be incorporated into future Camp Croft informational materials:

- **Safety.** The USACE is committed to effectively characterizing and cleaning up the former Camp Croft in a manner that provides the highest level of safety to the public, workers, and the environment.
- **Stewardship.** The USACE is a good steward of the environment as an extension of its professionalism. It implements effective policies and practices that safeguard the environment and public well-being in a manner that the nation expects.
- **Sustainability.** The USACE will not squander its precious environmental resources. It will use sound business and innovative environmental practices to align its current needs with those foreseen for the future.
- **Oversight.** The USACE will conduct its activities at the former Camp Croft in compliance with Federal, state, and local environmental policies.
- **Partnership.** The remedial investigation process at the former Camp Croft is conducted through a partnering effort among the USACE and SC DHEC.
- **Public Involvement.** The USACE encourages the public to learn more about and become involved in its munitions response activities at the former Camp Croft.

b. Communications with each target audience will include these messages and be tailored to meet specific information needs and interests. Additional specific messages will be developed according to specific projects and/or milestones.

4.2 COMMUNICATION ACTIVITIES AND TECHNIQUES

- a. The USACE follows EPA guidance for community involvement and preparing the CRP for CERCLA and Military Munitions Response Program (MMRP) response actions. In accordance with EPA guidance and EP 200-3-1, USACE will establish and maintain an AR/IR, facilitate public meetings, and maintain the RAB (as public interest warrants).
- b. In addition to these required community involvement activities, the USACE may initiate other activities to communicate information to the public and to promote community involvement in the former Camp Croft FUDS project.

Restoration Advisory Board

Objective: To provide citizens with a meaningful way to become actively involved, and to provide the USACE with a viable means of learning citizens' concerns and perceptions firsthand.

Action: A RAB is currently active and meets quarterly, based on agenda items.

Develop and Distribute Informational Materials

Objective: To proactively educate the community about munitions response actions and keep stakeholders updated on its status and progress through clear, accurate information.

Project Website

Objective: Mechanism to relay project-specific information to the public and the project delivery team (PDT) at an Internet WWW page.

Action: The Camp Croft website is active at www.campcroft.net. The website contains the site history, maps, fact sheets, meeting transcripts, and historical and project-related documents.

Media Relations

Objective: To issue notices for meetings and to encourage accurate media coverage of major events or milestones.

Public Meetings

Objective: To meet regulatory requirements and to update the community on progress and address community questions, concerns, ideas, and comments.

Public Comment Periods

Objective: To meet regulatory requirements and to give community members an opportunity to review and comment on remedial action decisions and plans, and to provide the USACE valuable feedback for use in the decision-making process.

Responsiveness Summaries

Objective: To summarize comments received during comment periods, document the USACE’s process for considering those comments during the decision-making process, and provide responses to comments.

Administrative Record/Information Repository (AR/IR)

Objective: To provide residents with access to the documents and resources used by the USACE to reach decisions about the remedial action decisions. The AR/IR for Camp Croft is located at (see Appendix D for addresses):

Revise CRP

Objective: To identify and address community concerns and preferences regarding munitions response activities. CRP updates may include community interviews and involve an assessment of past community involvement activities, community concerns, and communications activities and methodologies.
